Annual Shareholders' Meeting

You should have all received the May 19, 2020 letter from the Board (hardcopy under your apt door, email, and/or mailed to shareholders with outside addresses) outlining changes for the 2020 Annual Meeting of Shareholders and solicitation of Board members.

Due to the current health crisis and physical distancing guidelines, we are postponing our usual Annual Meeting and Election to the Board from its traditional date in June. The Board will be discussing a variety of scenarios at the next Board Meeting in July. The broad range of options stretches from a minimum distribution of a summary document describing the state of the building over the past year (financial and other information but no meeting, and no elections) to a full platform including much of what is traditionally held annually, that is, a meeting (in this we have located in the Laundry Room case via video) to discuss financials and building issues followed by elections to the Board via Directed Proxy/Ballots. Or something in between! This is all new territory for all of us, and the Board will discuss what will be in the best interest for all shareholders given the limitations presented by the health crisis.
