Annual Shareholders' Meeting

The Board was so happy to announce we would be having an Annual Shareholders Meeting this year! Of course it would have to be virtual, but thanks to the resources of our DEPM accountant executive, Amy Ahne, we were able to pull it off by hiring two outside companies. We hired one outside company, represented by Vicki Chesler, that specializes in setting up, conducting, and moderating the virtual meeting. The second outside company we hired, Honest Ballot, distributed the official notice of meeting, all associated materials, and most importantly conduct the official voting process of new Board members.

We are pleased to announce that 66% of the Coop was represented for a Quorum either virtually at the annual meeting on June 21, 2021, by online voting, or by proxy, which represents 108 Shareholders owning 24,816 shares of the Corporation. Total online votes were 103 representing 23,562 shares (with 1 abstain) and total proxies received 5 representing 6 units for 1,254 shares, but 1 proxy void for an online vote, tallied were 4 representing 5 units for 1,100 shares.

The following shareholders, in alphabetical order, were elected to serve on the Board of Directors for the 2021-2022 term: Christopher Gembinski, Nancy Gross, Elizabeth Haynes, Roxanne Klinger, Jon Medwick, Charlie Starner, and Brandon Teitelbaum.

Your Board wishes to thank everyone that attended the annual meeting and the great show of interest in the operation of the building.
